

Why "The Ranger"?

Poke Run Church goes back to pioneer days and has always been a forward looking and advancing congregation. In response to The Great Commission - (Matthew 28:17-20; The Acts 1:8) the influence of Poke Run Church has gone forth to all the earth. Since the dictionary definition of "ranger" is "the keeper of a royal park or forest" - so "The Ranger" suggests the desire of Poke Run Church to maintain her evangelistic zeal over a wide area and to always hold a concern for people everywhere in the name of Christ.

On April 23rd, the Poke Run congregation worshipped in the newly remodeled Sanctuary for the first time. Truly, we "worshipped the Lord in the beauty of Holiness." For it was an inspiring setting - the mellowness of the old woods blending with the oak of the new pews, pulpits, communion table and other appointments - the red carpet throughout - the soft colors of the old windows so handsomely restored - the gold cushions in the pews - the colonial type chandeliers - all this the culmination of several years of planning, working, visualizing.

Then on Mother's Day our pastor, Mr. Roy S. Brice made his first appearance in a white pastoral robe, a gift by the Jack Blair family in memory of Mr. Blair's mother, Mrs. Dora Blair.

There have been several other generous gifts adding to the beauty of the Sanctuary that will be mentioned at a later date when we have time to "get it altogether".

The South end of the Narthex (where the old Session Room used to be) has been designated by the Session as a place of prayer at 9:45 A. M. each Sunday morning. The Men's Class is making plans to reconvene.

The formal dedication of The Sanctuary will take place on Sunday, June 25th, at 3:00 P. M. We hope that many former members and friends will plan to be with us on that day. A reception will follow in Fellowship Hall.

## FACTS AND DUTIES PERTAINING TO THE

- a. Membership, Spiritual Life, and Social Service Committee (Entire Session)
1. Spiritual care of membership in accordance with known needs, with endeavor to keep Pastor informed of special needs.
  2. One individual or new family each year by each member of the Session as a minimum membership-strengthening goal. (It is hoped that the Board of Deacons and the Board of Trustees will also view this as a reasonable membership-strengthening goal for each member of these bodies.)
  3. Direct personal renewal of interest in the educational program of our congregation -- this personal renewal of interest to include:
    - Personal enrollment in one of the classes of our Sunday Church School;
    - Endeavor to procure the enrollment of others of our congregation;
    - Outreach-enrollment and extension of the services and instruction of our Church School to the non-churched of our community;
    - Visitation from time to time by individual members of the Session to the various classes and departments of our Church School, thus giving evidence of interest and support of the work being done by our teaching staff;
    - Being on hand at 10:00 A. M. on Sundays to greet, welcome and help create an interesting and friendly atmosphere for those assembling for participation in the Christian Faith and Action program;
    - Being expressively grateful for the extensive educational program of our Women's Association, with readiness to give all possible assistance and cooperation to the members of the Association as they continue with their outstanding activities.
  4. Assist -- as needed -- with the Youth Program; with the general work of the Board of Deacons; with the projects of the Board of Trustees; and with the work of other groups and special committees.
  5. Encouragement of total commitment on the part of the membership to the cause of Christ -- in terms of time, talent, and financial resources.
  6. Deepening of spiritual life and fellowship and maintaining of Christian standards in total life of congregation -- including adjusting roll as may seem proper through suspension and erasure.
  7. Each Ruling Elder being faithful in his individual administrative committee assignments -- knowing that he is not alone, remembering that the Whole Church under the Headship of Christ is called to Ministry in: preaching, teaching, healing, and in loving concern for others. However, may the homes of Ruling Elders be especially marked by the practice of the devotional life, to the end that those who dwell there be resources of spiritual strength and guidance to others. Let intercessions be made for the Pastor before and during each Service of Worship and at all other needful times; and may the intercessions of the Pastor be united with those of the Ruling Eldership, to the end that under demonstrations of the Spirit all might embrace the knowledge of Christ crucified, that the faith of our congregation "Might not rest in the wisdom of men but in the power of God." (I Corinthians 2:5)
