For you who were not privileged to attend the Poke Run services during the Advent season, we shall give you the highlights briefly. On Sunday, November 30,1980, the first Sunday of Advent, the congregation was greeted by the lovely vision of the tall Christmas Tree whith its many handmade Chrismon ornaments and white lights (courtesy of Circle 4 and husbands). The evergreen wreaths on the church doors and the tall red candles and evergreens in the narthex windows also proclaimed the holiday season. The Metzgar family - John and Judy, Jim, Tom and Heather participated in the Candlelighting Advent Wreath ceremony. Rev. Brice's sermon was entitled "The Divine Intervention", and the choir sang "Lo, How a Rose E'er Blooming". The flowers in the planters this day were given by Mrs. Florence McKown Kepner in memory of her late husband, Norman Kepner, and her parents, Mr. and Mrs. D. K. McKown. On December 7, 1980, the white poinsettias in the planters added another festive note to the seasonal decorations. These were given by Marie and Edgar Brewer in memory of all Poke Run members who have passed away. The Candlelighting ceremony was performed by The Lengauer family -- Don and Pat, Allison, Kelly and Kyle. Ronna Ryman sang the solo "Sleep, O Holy Child, and Rev. Brice spoke on "Getting Through Christmas". "Merry Christmas" was the theme of his sermon on the third Sunday of Advent, December 14, 1980. The Marvin P. Moneymaker family, Marvin and Kathy and daughters Lori and Becky, and Mrs. Richard Ryman, Sr., conducted the Advent Wreath ceremony. The anthem, "We Worship You, O King of Love" was rendered by the choir. On this day white candles flanked by evergreens graced the windows in the sanctuary (courtesy of Circle 4). On December 21, 1980, the Fourth Sunday of Advent, John and Anna Hughes, William and Evelyn Shaeffer, and Amy Gebrosky were in charge of the Candlelighting ceremony. Rev. Brice's message was entitled "All But One". The cantata, "The First Christmas" by Parks, was presented by the choir. The cantata was narrated by Mr. Brice, Brenda Hostetler, Ruth Ryman and Nadene Dunmire. Soloists were Mrs. Richard Ryman, Sr., Mr. Donald Lengauer, Mrs. June Penrod and Miss Amy Gebrosky. Mrs. Terrence Lewis directed the choir and Mrs. James Dunmire played the piano accompaniment. The joyous story of Christmas from that meager beginning in Bethelem to the coming of the Wise Men to see the Carist Child unfolded as the cantata was sung.

The Traditional Candlelight Service sponsored by the Board of Deacons was scheduled for Christmas Eve this year, but due to the severe winter weather the Carlielight Service was postponed until the evning of Sunday, December 28th. For you people who enjoy tracing local family trees and hearing historical sidelights pertaining to Poke Run, an interesting letter written in 1885 has been brought to our attention through the courtesy of Mrs. James Zimmerman (Jane Alcorn), who obtained it from an old family Bible. The letter (a copy of which follows) was written to the Rev. Henry Bain, fifth pastor of Poke Run Chruch, from the Board of Missions in New York, on the occasion of the untimely death of the Rev. James T. Young, a son of Poke Run Church and an uncle of Mrs. Joseph N. Alcorn (Mary K. McElroy.) The children of Mr. and Mrs. Alcorn were Katherine Alcorn Rise (deceased), Jane Alcorn Zimmerman, Margaret Alcorn Ewing, and Joseph N. Alcorn, Jr., all of whom were baptized at, and members of Poke Run. Mrs. Alcorn was the daughter of Polly Harper Young (an older sister of the Rev. James T. Young) and Matthew Shearer McElroy.

From the Poke Run History we learn the sad but inspiring story of the brief life of James Theophilus Young, born in Westmoreland Co. on July 20, 1854, son of John L. and Mary Christy Young. He joined Poke Run Church in 1874 and completed his work at Western Theological Seminary in 1882. The same year he was married to Lizzie Phillips. His dream was to be a missionary on the foreign field -- so he was appointed to go to China by the Board of Missions, but tragically his health began to fail so when the time came he could not go. In 1884 he was installed as pastor at East Conemaugh where he served until his death at the age of 31 in 1885. The History tells us that in his last days children of the church would pull him there on a sled and the men would carry him to the pulpit. Truly a dedicated servant of the Lord! Rev. Young was buried in the Poke Run Cemetery. Below is a copy of the letter.

It is with real regret that I learn the sad news of Mr. Young's early departure. For him it is all well. We ought not to sorrow chiefly for his removal to his rest and his Saviour's presence; but for friends and kindred and for the cause which he had so much at heart, we may indeed mourn. It is one of the mysteries of Providence. But God knows what is best. The Saviour's love and grace may thereby be manifested in ways that we do not understand.



SOME FACTS AND FIGURES FROM THE EVERY MEMBER CANVASS COMMUNICATION

The average per member sum of \$89.68 plus is needed to carry the financial load of our annual budgetary needs (Current and Benevolence). In attaining this average contributions are presently ranging from \$? to \$1,397.00 plus, with many of the membership giving in terms of \$600.00 and above.

Think about this:

The Membership Per Capita Assessment for the Year 1980 is \$4.38. This means that in the Year 1980 Poke Run Church has paid out for the total membership the total sum of \$3,530.28.

The Membership Per Capita Assessment for the Year 1981 will be \$ 5.29. This means that in the Year 1981 Poke Run Church will be paying out for the total membership the total sum of \$4,194.97.

How does this relate to the stewardship of individual members? Below is an example, based upon the 1980 per capita rate of \$4.38.

Example

Let us suppose that Mr. and Mrs. Churchman and their two children (John and Jean) have their membership at Poke Run Church. The total per capita for the Churchman Family will be as follows: \$4.38 for Mr. Churchman

4.38 for Mrs. Churchman



Total per capita for the Churchman Family\$17.52

(It has been calculated that the additional administrative cost, including postage, adds up to approximately \$9.74 per year per family -- this sum added to the above sum of \$17.52 makes \$27.26. Churchman Family, your help is needed!)

Let us further suppose that the Churchman Family fails to contribute in the Year 1980. This will mean that of necessity the per capita for the Churchman Family must be paid by the contributions of others; and it is really very likely that the Churchman Family would much prefer it otherwise.
